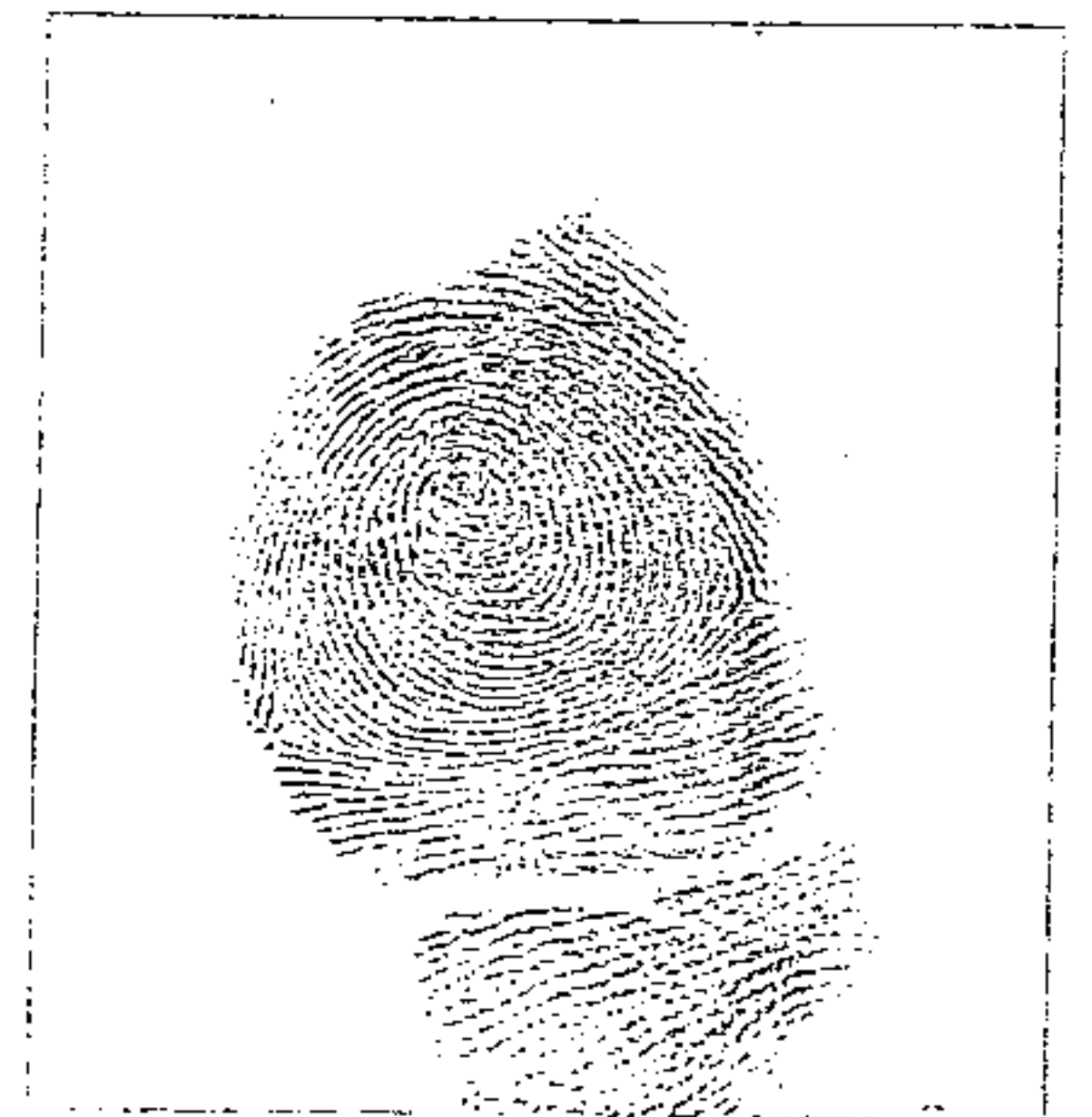
Witness  Victim  Officer stated he/she saw/heard the following:
